We have already seen that no partition can be had so long as the survivor elects to occupy it, or the guardian of the minor children is permitted by order of the probate court to occupy it.16 During the life of the parent the homestead right of the child is asserted through such parent, in the absence of an order authorizing the guardian in a proper case to occupy the property as homestead, and on abandonment by the par...
